PRE-CONVENTION BOARD MEETING

Thursday, July 21, 2011

Discussion of 2010 meeting minutes

Motion-Caren Schuman: Approval of Pre-Convention Board Meeting, General and Board 2010 meeting minutes; Second-Donna LaRoux; Motion carried.

Review of Board members representing districts.

Review of Board members absent.

Review of finance report.

Discussion of new finance committee members, for review of financial statements.

Discussion of receiving 501c5 status as opposed to 501c3, and the implications being that we are not required to pay taxes; however, we still must pay sales tax and are not eligible for tax deductions on donated funds.

Discussion of lost records of full registrations 3600-3700 and PB 300-423 and what action we would attempt take to recover these records.

Discussion on progress of stud book. Have decided it will be necessary to scan and send all hard-copy records to Caren in order for her to complete the stud book and make the appropriate corrections to the current stud books.

Motion-Caren Schuman to scan and send all hard copies to her for stud book; Second-Sue Davis; Motion carried.

Discussed current office status. Melinda stated that all is currently going well; however, she discovered that in addition to rent, utilities are to be paid, which she previously thought was included in rent cost.

Discussed "CA" issues and implications that might affect the Registry and what approach we need to take. We have been approached by the ICHO to participate with them in an ongoing research study regarding "CA" and the Curly Horse. We have decided to participate in this study. Sue Davis is willing to be the representative for the ABC in this study. Further discussion and decisions to continue at Membership/Breeders meetings.

Discussed continuing dilemmas with the *Curly Cues* both in timeliness, content and costs. Sue Davis presented an alternative with the *Equine Journal*. Discussion regarding the by-laws involving a change and it was decided that if we called the *Equine Journal* page the *Curly Cues* and listed the breeders 3X per year we would still be within the parameters of the by-law. It was then decided that this was a worthwhile presentation to bring to the members at the Membership Meeting. Caren expressed concern regarding the European members, as she felt this journal too "Americanized" for the European members. It was discussed to possibly have her produce a short, two-page newsletter for those members and have her send them out either quarterly or monthly. The Canadian district would then need to decide which route they would prefer.

District 8 was up for election and no candidates applied. Greg Oakes expressed a desire to not be re-appointed. Discussion of how to proceed with finding a representative for Canada/Alaska was continued and whether to appoint someone from Canada/Alaska specifically or anyone willing to represent them. It was decided to see if anyone in Canada or Alaska was willing to step up to the plate or if we would need to assign. It was decided to ask the Canadians/Alaskans how they would prefer to proceed.

Discussion of the continuing problem of website improvements and updates, and their costs with the current webmaster were discussed. It was felt that the improvements and updates as currently being done were not a good value for the cost, both by webmaster as well as the server costs. Joan Olson had done some research as to the cost and benefits of a different server that would provide a better value for the money. It was also felt that the Registry would best be served by a webmaster that is closer to the Registry and would be willing to maintain updates in a more efficient and timely manner. It was decided that the best route would be to completely start over with a new website, new server and new webmaster. Daryl Lang offered his sister to rewrite the website along with the help of Caren Schuman and that Joan Olson would then take over as webmaster. This will be taken to the Membership Meeting as well.

Discussion of Facebook page. The Facebook page that was established by Samantha has been removed. It was discussed whether it would be in the best interest to re-establish. There was conflicting feelings regarding this issue. The issue was not resolved nor any decisions made at this meeting.

Discussion of at-large ballots not being received by European members and what action to take. Apparently, it was found that one of the candidates was not eligible for election due to the fact that her membership had fallen into arrears and she did not respond to inquiries regarding making her membership current. Therefore, it was found that the other member was running unopposed so ballots were not necessary.

Motion to adjourn Daryl Lang; Second-Sue Davis; Meeting adjourned 10:00 p.m.

Committee reports published in Convention booklet and available for membership review.

Research committee-will be cooperating with ICHO on "CA" research.

Scholarship committee-two people applied for scholarships and both will be receiving.

By-laws committee-nothing.

Hall of Fame-lost application for BB Copper Sun - still not found.

Marketing committee-Carol Baldwin asked about funding for Horse Fairs. Told that funding is determined yearly according to Registry budget. Sue Davis explained that Horse Fairs are one of our best resources for getting the Curlies out to the public and should have a high priority for funding, but unfortunately in the past year, due to other financial issues at the Registry, no funding was available but hopefully there will be funds in the future. Suggested trying to pool with other owners to spread out the costs. Melinda said that curtains and stall decorations are available for use from the ABC office on request. Some further discussion of particular horse fairs and their costs and suggestions. Angie suggested the possibility of taking horses to the Fort Worth Stock Show.

Melinda also stated that Caren Schuman and Carol Baldwin reworked the ABC brochure, and that they were now also available in multiple languages and could be downloaded from the website for member use.

District reports published in Convention booklet and available for membership review.

Motion-Donna LaRoux to approve the meeting program; Second-Daryl Lang; Motion carried.

Election of officers from membership ballot-Liz Mattke District 2, Alyssa Redvay District 4. No one running for District 8. Angie Gaines At-large Representative.

Stud book discussion. Caren Schuman discussed the complaints of mistakes and the length of time since a new stud book has been published. She went through record by record and found many mistakes. Could not compare database with stud books after full #3055, as well as corresponding straights 622 and PB's 561, as this is where the stud books stopped, so she could only go according to the database. She would like to compare the database with the hard files that are kept at the Registry in order to be sure the database is correct. She will do these in the next several months. Mel will have all records scanned and sent to Caren to be sure data base is correct. Plan to have one single complete stud book. At this time, the database only includes the number, name, sire and dam. Then we can add any additional information that is wanted.

Registration Certificates. Re the general consensus, several did not like the new certificates, some did. Discussion included the poor quality of pictures submitted. One suggestion is to return incomplete forms or inadequate pictures. Problems with the painted certificates also started showing up in the end prior to using the pictures. Suggestion to charge a small additional fee for painted certificates or to have the owner "choose" the picture they want in an attempt to encourage taking good photos. Melinda stated that when she needs additional pictures, she allows people to email pictures. Penny stated that an announcement that digital photos are accepted be in the Curly Cues.

Motion to temporarily adjourn-Diane Mitchell; Second-Leslie Getz-Jetz; Motion carried.

General Membership Meeting-reconvened at 11:30 a.m.

Zoe suggested seeking grants for available monies. Discussion of Fundraising, including T-shirts and belt buckles. Continued to suggest writing grant applications for different disciplines. Since we are a rare breed, the Curly may be eligible for some of these grants. It was suggested that an ad-hoc committee be formed for Grant Writing. Caren felt this should not be part of the Marketing Committee but rather part of the Ways and Means Committee.

Diane Mitchell discussed the acquisition of 501c5 status as opposed to 501c3 and its ramifications, which means we do not have to pay taxes but donated funds are not eligible for deduction. Need to announce in *Curly Cues* so all are aware.

Curly Cues and the website. Currently being managed by Heather in Canada at a rate of \$50/hour. Finding only specific things are being fixed but not following through. Decided that the best idea would be to start completely over with a totally new website. Joan Olson offered that she had researched some other web servers and found a better deal. Daryl Lang offered to have his sister, along with Caren Schuman, build the new website. Joan then offered to be the webmaster.

Discussion of *Curly Cues*. Sue Davis proposed going with the *Equine Journal* in place of the *Curly Cues*, which would offer ABC a page each month in the journal for \$7/member. All members would receive a copy each month, along with some free advertising. In order to stay in compliance with the by-laws, the page would be titled the *Curly Cues*. Caren expressed concern that the European members would not be interested, so it was proposed that perhaps she could send out a smaller newsletter to her members. We would still need to find out how the Canadian members would like to proceed, as we would need to send them to Canada ourselves. Caren is going to see if there is perhaps a similar journal available for the European members. Angie suggested putting the CC's information on Facebook. Was also suggested that perhaps District Reps write newsletters to their members on occasion....or monthly.

There was no objection to proceeding with *Equine Journal*. Betsey commented that the information submitted each month should be of good quality.

Motion to proceed with *Equine Journal* and establish cut-off date for membership payment to receive journal and other associated benefits at March 31 of each year-Betsy Lirakis; Second-Laurie Lee; Motion carried.

“CA” (Cerebellar Abiotrophy). Discussion of policy for breeders regarding “CA”. Sue Davis explained how the horses get CA and that it is an Autosomal recessive genetic trait. Overall discussion was that it is a matter of judicious breeding and is the responsibility of the breeder. It was decided that it is not the job of the Registry to police breeders. It was discussed that each breeder could have their horses tested on their own through UC-Davis and how to proceed. Caren suggested that we cooperate with ICHO on their research and education program on CA. Melinda said that she had been in touch with them and Sue Davis will be working with them on this endeavor.

Motion to put a public list on the ABC website of horses that are CA clear that is voluntary-Penny Johnson; Second-none; Motion dropped.

New Business

Penny Johnson brought several motions to the membership as follows:

Motion that an independent committee be formed from the general membership, excluding ABCR board members, their families or their close friends and business associates, to investigate rumors of services that were paid for but not received. This committee is to report its findings at the next ABCR Convention to be held in 2012. Second-none; Motion dropped.

Motion that ABCR will announce in the “CC’s”, in online Curly chat groups and other places to be determined later, that all of those who may have requested services and have proof of having paid for ABCR services which they did not receive may contact the ABCR and receive the service for which they have already paid. Second-none; Motion dropped.

Motion that the ABCR retract a statement made in a 2010 *Curly Cues* which may be considered offensive and that the ABCR make a public apology for having printed such a statement. Discussion included that this was an editorial comment and that the ABC does not take responsibility for editorial comments. Second-none; Motion dropped.

Motion that CHR not be named receiver of ABC assets should the ABC dissolve. Discussion explained that, in order to be a 501c5, it was a requirement for the ABC to name a 501c3 organization as the benefactor of any assets (money). This does not include the records. It was explained that the CHR is not a Registry and is not interested in the records of the ABC records and, in all actuality, if this situation should occur, then in reality the ICHO would most likely receive the ABC records, however ICHO must be involved with this decision.

Motion then changed that, in the case of dissolution, the ABC will relinquish all records to ICHO and that we will discuss with ICHO the distribution of such registration documents to them. Second-Betsey Lirakis.

Then a second motion that ballots be sent out to those members not in attendance regarding this issue.
No second-motion dropped.

Returned to first motion –Motion passed.

Angie Gaines came forward to discuss the possible registration of BLM Curly Mustangs. In her discussion, she presented DNA evidence of her Curly Mustangs are related to Copper D. She is imploring the ABCR to reconsider allowing the registration of Curly Mustangs, as they are the original heritage of the Curly Horse and, with DNA testing, continue to show relations to some of the early Curly horses. She emphasized that she is not attempting to bring in outside breeds, only the horses that are the heritage of the breed.

Also brought up at this time was the issue of not allowing Percent blood stallions to full mares, while allowing Percent blood mares to full stallions. There was some discussion about the fact that this was the same genetically. Melinda suggested that this issue be addressed by the By-laws Committee.

Discussion continued about the possible future of ABC and ICHO merging in some manner.

Motion to adjourn-Diane Mitchell; Second-Fred; Motion carried.

Discussion was opened regarding the allowance of Curly Mustangs into the Registry. How would that affect not only the rule barring the registration of horses from percent blood stallions as well as the closed stud books? What is the mission of the ABC, what are the ramifications of such an action? How would the horses be classified? Diane Mitchell explained that Ann Bowling felt that we should close the books in order to establish the Curly as a true breed and continue to breed Curly to Curly. The integrity of the Curly gene must be maintained; however, there is some belief that we could have separate "books" for the Curly, which might allow for percentage blood horses.

The original Prince Philip Cup was donated to the British Pony Club by His Royal Highness, Prince Philip, Duke of Edinburgh. The Western Ontario Region requires players to have achieved a minimum standing of D Level before competing. Their motto: SPORTSMANSHIP, CHARACTER, LOYALTY AND FUN!

The ABC Registry and its New Tax Exemption

Submitted by Diane Mitchell, ABCR Treasurer

For over a year now, I have worked, filled out forms, discussed and negotiated with the IRS regarding the ABC Registry becoming a 501c3 Corporation. This is a status that had never been applied for, and I felt the organization would benefit financially from it.

Over the past year, the IRS has made changes: anyone wishing to be a 501c3 now needs to be a hospital, church, school, have youth programs (like 4-H), help the community (like Habitat for Humanity or homeless shelters), or rescue children, the elderly or animals.

Because we, along with the other horse registries out there, do not belong in any of these categories, we are not allowed to be a 501c3. However, we are now accepted as a 501c5. (That's a "head's up" to those of you who belong to other registries.)

What is a 501c5? This status provides tax exemption on profits; thus, we do not have to pay taxes on profits. They made this retroactive, so we are not required to pay any taxes since being formed in 1972. If the Registry purchases an item, we do pay sales tax on it. We fill out yearly statements, due in May of each year. We do pay a small annual fee to Nevada to maintain our incorporation status.

It also means that any donation to us is not tax deductible; you can't write off donations on your own taxes. Sorry. This will potentially hurt us, but their response is for the Registry to be more active in fundraising. Also, the ABC Registry is a business, and if you have a horse business, all financial dealings with ABC Registry are a business expense.

Due to reductions in donations, we need to be more active in fundraising. Our Ways and Means Committee, headed by Angie Gaines, has been renamed to the 'Fundraising Committee'. We ask our members to think of ways to raise money, increase membership and methods to sell items, particularly items we already have in stock, such as the T-shirts and decals.

Please continue to be supportive of the Registry. The ABC Registry is an organization you should be proud of, and to continue to support by being a member and promoting the breed. Just as our horses are unique, so are we in preserving them!

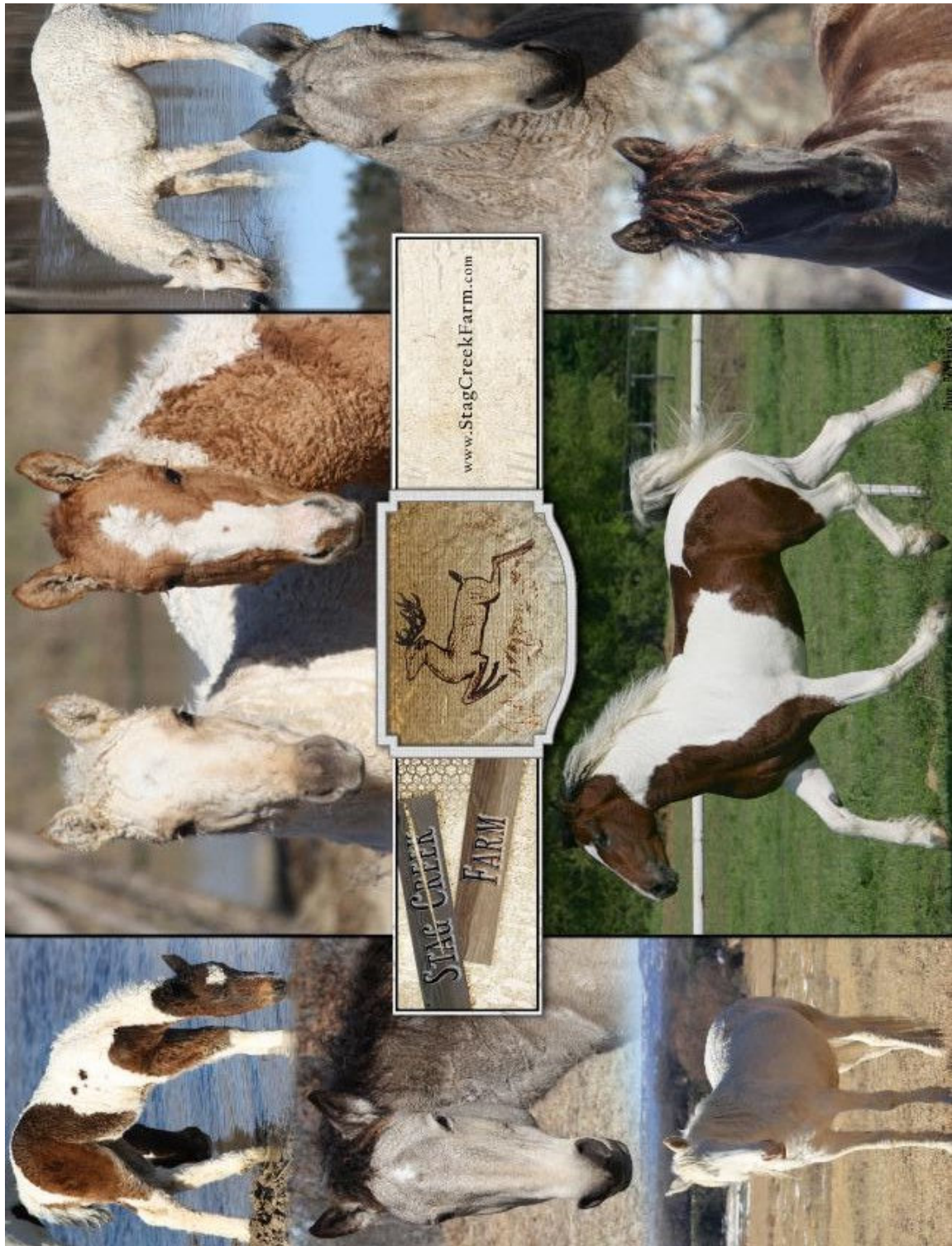

2. Entry
