Soon, his attention turns to playing with herd mates and spends more time eating grass. This is when we need to step in and help our new equine friend with added protection by building his immunities with vaccinations. Here is a recommended schedule of vaccinations for your foal. Note, please consult with your local veterinarian as the area of the world in which you live, your equine exposure to diseases such as West Nile may be stronger, and your foal health should be taken into consideration when vaccinating.

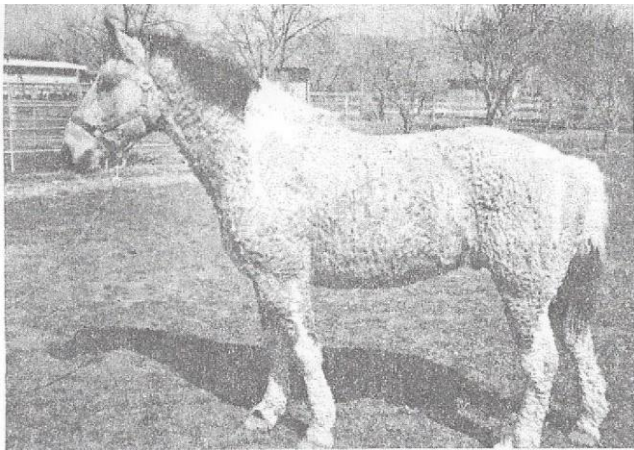

Our District is large but has few active members. According to the ABC Website I am the only active Breeder in Nevada. This year we had 2 ABC babies, one curly, one straight. We decided not to breed for 2016 due to the economy. I have contacted one of my District 1 members and asked her to give a report on her Curly antics. She is very active in Trail competitions, something we enjoy doing also here in Nevada. Tiffany Washington is a 3rd generation Curly Gal, following in the footsteps of her Grandmother and Mother, not to mention a great influence from her Father too, a past President of the Registry. Here is Tiffany's report, enjoy!

Over the last year and a half my 7 year old Gruella Curly horse gelding Takoda Moon ABC-3924 and I have been doing any kind of competitive Trail competition we can find in California. We have done Trail Trials where you go out on a 2 to 3 hour ride and do 10 obstacles that are spread out throughout the ride and are judged at each obstacle. There are many local clubs that put these on. Then there is Cowboy Challenges/Racing which is a timed event with 13 natural and unnatural obstacle that can be in a large arena or open field. This is judged mostly on the horsemanship of you and the horse with speed being only a small part of your score. Some of the Associations are Extreme Cowboy Association and the American Horsemen's Challenge Association. So if you like going fast and doing obstacles this is a lot of fun to do.

Takoda and I have won many awards in these events. In the last year and a half we have won a belt buckle at a Trail Trial series in the Open Division in 2014. We won 2 belt buckles at a Cowboy Challenge Series one in Amateur and one in Open 2014. This year we have been off to a slow start due to me having a baby in April. But I have recently started competing again. I have been going to a local Cowboy Trail Race and have won first in the open division. I will be attending another Cowboy Trail Race at the end of August too. In September and October I will be competing in a Cowboy Challenge Series near Mariposa and hopefully bringing home another belt buckle.

I am really looking forward to 2016 because I am hoping to compete in the Charles Wilhelm Ultimate Super Horse Challenge at either the Western States Horse Expo in Pomona or the Western States Horse Expo in Sacramento. In a few years I am looking into traveling to Eugene Oregon and compete in the indoor National Mountain Trail Championships at the Oregon Horse Center.

I am not only doing this for myself and my horse but to promote this wonderful American Bashkir Curly breed that we all have come to love and enjoy. I want to show the public that these horses are very versatile and can do anything with the right training.

AMERICAN BASHKIR CURLY REGISTRY BY LAWS

Revised October 2009

ARTICLE I

TITLE, OBJECT, AND PLACE OF BUSINESS

SECTION 1.

The name of this association shall be the AMERICAN BASHKIR CURLY REGISTRY. It shall, at all times, be conducted as a nonprofit organization according to the laws of the State of Nevada in which State it was incorporated August 12, 1972.

SECTION 2.

This organization shall proceed as a closed Registry. The Registry's purposes shall be to: issue certificates of registration, track pedigrees, preserve and propagate Curly to Curly breeding to obtain genetic stability, and promote through competition and other horse related activities, public understanding of this unique breed.

SECTION 3.

The principle place of business for the American Bashkir Curly Registry shall be any state of the United States where business may be conducted that is efficient to the operations of the Registry.

ARTICLE II

MEMBERSHIP

Section 1-Classification of Membership

- a. Individual Senior Membership - any person the age of 18 or older. Senior members are eligible to hold office, serve on committees and vote on Registry business. They are also eligible for scholarship and award programs.
- b. Individual Junior Membership - any person under the age of 18. Junior members are eligible for scholarship and award programs, and attend general business meetings of the Registry. They are not eligible to vote or hold office.
- c. Family Membership – any Family unit consisting up to 2 adults and their children under the age of 18. Adult members have the same rights and privileges of the Individual Senior member. Children are junior members and therefore have the same rights and privileges of the Individual Junior member.
- d. Life Membership – any Senior member who paid a one-time fee as prescribed by the Board of Trustees at the time of membership. Life members have all the rights and privileges of a Senior member.
- e. Breeder Membership – any Senior member who is also a licensed breeder. They shall have all the rights and privileges of a Senior member.

Section 2 – Eligibility for Membership

Eligibility for membership is contingent upon receipt of the appropriate fees by the Official office of the American Bashkir Curly Registry and as prescribed by the Rules and Regulations adopted by the Board of Trustees.

Section 3 – Administration

a. The amount of dues shall be set for each membership classification by a majority vote of the Board of Trustees.

b. Dues are payable on January 1 of each year. Dues paid by new members after October 1 shall be good through the following year.

New b. Membership is for 12 months and renewable in the month of the prior year's payment.

c. Membership cards are non-transferable and shall carry the signature of the Officer or Officers as designated by the Board of Trustees. It may bear the Registry Seal or a facsimile thereof.
