Fellow Curly Members,

I am feeling the cold this morning!! Woke up to 20 degrees here in Reno, Nevada.

It amazes me how a horse can stand it outside at night in that deep freeze. If they have adequate time to grow a winter coat there is no worry. Just make sure that they have enough drinkable water to stay hydrated. A horse will not consume enough snow to meet its water requirement.

Blankets can provide a barrier to the cold and snow. The outer surface should be a durable material like canvas fabric and check the blanket regularly for any damage so the horse cannot get caught up in it. If your horse has been living outside through the fall and into the winter months with no problem then it should be okay without blanketing. Also make sure they have enough forage to provide inner heat to maintain its body temperature.

Our Curlies are never blanketed, their thick coats keep them warm. It does take some time for them to dry out after a workout session, we usually let them loaf in the barn till then and out they go.

It will soon be the end of 2024, time to start thinking about the new 2025 breeding season. I hope that everyone who can breed exceptional Curlies will and raise those foals to be the next ambassadors of this awesome breed.

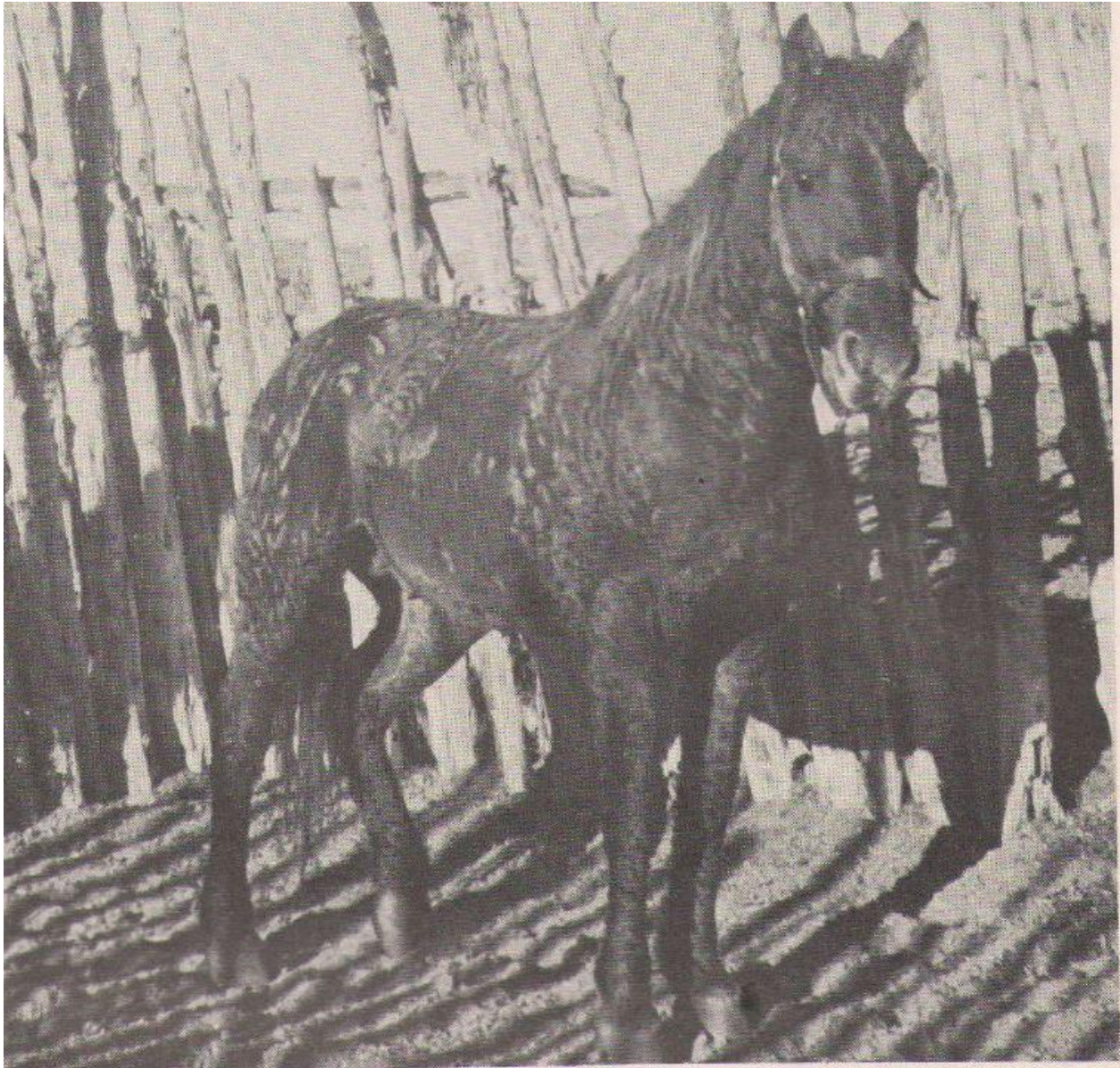

#### Quick recap

The meeting involved discussions on various topics, including personal updates, technical issues, and business matters. The team also discussed the financial status and budget for the year 2023 and 2024, with a focus on fundraising challenges and the need for more proactive support. Other topics included website and merchandise issues, the possibility of using Cafe Press for merchandise sales, and concerns about the identification of horses with specific genetic traits. #### Summary

##### Personal Updates

The group approved the 2023 minutes and discussed membership reports, focusing on the number of breeder and adult members. Diane's status as a life member was also discussed, with Melinda explaining the challenges of tracking them in the system. The conversation ended with Melinda suggesting the addition of a fundraising item under old business in the agenda.

##### Financial Reports and Budget Discussion

The meeting involved a discussion about the financial status and budget for the year 2023 and 2024. Melinda presented the financial reports for both years, highlighting the differences in salaries and expenses. She also mentioned the purchase of a printer and a computer in the previous year. The team discussed the budget for the current year, with Melinda noting that they are currently at about \$2,000 to the good. The team also discussed the 100-mile contest, with Tiffany being the only participant who came close to completing it. The team then accepted the financial report for the year 2023.

##### Fundraising Challenges and Support Strategies

Diane reported a balance of \$1,586 after providing \$753 in assistance and receiving \$557 in donations. She expressed disappointment at the lack of donations and mentioned a fundraiser and efforts to renew a logo contract. The team discussed fundraising challenges, with Melinda suggesting sharing Diane's Venmo for donations, which Diane agreed to. They agreed on the importance of raising November funds and the need for more proactive support, while Melinda expressed concern about requests for additional assistance after initial help.

##### Website and Merchandise Issues Discussion

The team discussed various issues related to their website and merchandise. Caren reported that everything was fine with the website. Diane raised an issue about needing to sign in to access the website, which Caren attributed to a possible firewall issue. Melinda brought up the topic of merchandise, mentioning that they still have red T-shirts, hats, and sweatshirts available. However, she expressed concerns about sizing issues and the need to decide what to do with the current stock. Shawn and Joan mentioned that they had used a site called Cafe Press in the past, but there were issues with internet connectivity due to a storm. The team also discussed the possibility of changing the picture on their T-shirts.

##### Cafe Press Merchandise Sales Discussion

Melinda, Shawn, Caren, Joan, and Diane discussed the possibility of using Cafe Press for merchandise sales. They agreed that the products would be sold through Cafe Press's store, with a link provided on their own website. The pricing and profit-sharing details were to be

clarified by Shawn. The team also considered the possibility of shipping to European locations. Shawn agreed to look into these details and share the information with the team.

#### **Genetic Traits, Certificate Design, and Database Tracking**

Melinda raised concerns about the identification of horses with specific genetic traits on their certificates and in the database. She suggested advertising these traits to breeders and questioned whether there could be a way to identify these horses specifically. Shawn sought clarification on the registration form. The team decided to change the color of the registration seal to a more neutral shade such as beige or off-white, to improve its appearance. They also discussed the possibility of tracking genetic information in the database, but decided to revisit this issue later.

#### **Curly-Coated Horse Code Book and Breeding Rules**

Melinda expressed concerns about the Curly Code Book horses and identifying those with unknown heritage. The team debated rules for breeding curly-coated horses with other breeds, with Joan suggesting consistent rules across breeds. They discussed aligning registration rules for Curly Coat and Mustang breeds, with Melinda arguing for equal treatment since both are registered. The classification of horses based on heritage and DNA was also discussed, with Caren clarifying the difference between outcross and mustang/curly sections. The team agreed to further discuss potential rule changes.

#### **Horse Registry Proposal and ABC Background Discussion**

Melinda, Joan, Sonja, and Caren discussed the concept of registering horses in their registry, particularly those with unclear heritage. They agreed to create a written proposal to present to the board for discussion. The team also discussed the registration of horses with ABC backgrounds, with Melinda proposing registration provided they are identified as unregistered. The horses are being added to the database, and their pedigree will show their ABC background. The team also discussed the database's effectiveness in tracing horse lineages from the DNA data, with Caren suggesting encouraging participants to provide parental DNA if available.

#### **Addressing Facebook Page Control and Engagement**

Caren gave control of the Facebook page to Kelly in 2017, who used her personal account, raising concerns about liability. The team agreed to explore rectifying the situation and removing Kelly's administrator access. They also discussed the need to engage younger people due to declining interest in horse riding related to economic and lifestyle changes.

#### **Horse Updates, Growth, and Officer Candidates**

Sonja shared updates about a horse called Oakesmuir Magnolia and two horses adopted by a polo family. Melinda reported growth in District 7 with new members and a breeder, and a horse

sold for combined training. The team discussed their current horses, the upcoming board meeting, and potential officer candidates. DMS mentioned winning her first belt buckle.

#### **Aging Horses, Breeding, and AI Discussion**

The team shared their personal experiences with their aging horses, discussing issues such as ocular cancer and the challenges of caring for them. They also discussed the increasing interest in artificial insemination for breeding horses and the potential for setting up an AI station on one of their farms.

#### **Discussing Storm Damage and Donation Efforts**

The team discussed the significant damage and loss of life caused by a recent storm in Florida's Panhandle and the Carolinas. They talked about the need for donations, with Diane agreeing to send out a list of contacts. Joan and Melinda discussed an issue with a registered DNA test for a horse, with Melinda agreeing to verify and cancel any duplicate entry. They also talked about horses with multiple DNA tests and registrations.
